What is Thriving Communities Technical Assistance?

The U.S. Department of Housing and Urban Development's (HUD) <u>Thriving</u> <u>Communities Technical Assistance program</u> is designed to help local governments ensure housing needs are considered as part of their larger infrastructure investment plans while also supporting equitable development in disadvantaged communities.



How will Thriving Communities TA support the City of Rockford?

The City of Rockford has two transportation infrastructure projects occurring around the downtown area. Through an MOU with the State of Illinois and the Rockford Mass Transit District, the City is utilizing USDOT Rebuilding American Infrastructure with Sustainability and Equity (RAISE) funding for the Rockford Complete Streets Revitalization project. This project will connect the east and west of downtown Rockford and bring bicycle and pedestrian improvements. The City was also recently awarded a USDOT Reconnecting Communities and Neighborhoods grant to support the 6th & 9th Street Two-Way Conversion project, which will bring bicycle and pedestrian enhancements, new open space, and development opportunities.

The City of Rockford, IL has requested Thriving Communities TA to further three key goals:

- Identify housing needs and articulate a housing strategy
- Create a **shared vision** for housing among elected officials, city staff across agencies, housing developers, and residents that is **feasible and implementable**
- Advance residential development, including on the City-owned green space available near the 6th & 9th St Two-way Conversion
